## CPF BBQ - update

- $\quad$ Some issues arose regarding using Cheques for BBQ order payments, 1 NSF cheque, 1 unsigned cheque. Took until September to be able to close orders.
- ATB offered e- transfer for payment, issue is with how to match with bbq orders,
- Too many late orders, deadline is deadline this year.
- Hot Lunch will offer to add online payment, Ady to discuss with HL at December meeting. Write CPF a cheque after bbq orders finalized. Should help alleviate a lot of issues and time entering payments.
- Some families still reluctant to use online program, Sandy was bombarded with certain individuals wanting only paper orders. Connie suggested those people who wish to not use online can come order day of and hope for best. Board agreed. Simplify process for all involved.
- Krispy Kreme Donut profit was 487.75 (There was 125 dozen ordered, 3 boxes spoiled, minus Delivery fee) All in all pretty easy way to make money.
- Carolyn reported feedback from school families was mostly positive online, Ady reported families said it was more organized, pick up layout went well, food out quickly, smaller lines, BBQ volunteers felt 2 bbqs were great, and will continue.
- Carolyn reported hearing some negative comments about Cotton candy being too small. Val \& Ady mentioned it as our $1^{\text {st }}$ time making, we packaged too quickly, we will change for future events.
- Board members felt lots of volunteers, well managed
- 1 M\&M receipt unpaid as unsure who to Pay. Receipt is for Ady Arbuckle.
- 1 SMHA receipt needs corrections, then payment to Vania Lloyd for same. (Alicia Ponciano has corrected receipt)

## Admin Report - Helene Hewitt

- Summer French reading program was success. Kids received a prize for bringing back after summer break.
- Update on French Grant for Field Trip "flying canoe", Helene was able to book all French students into the field trip.
- AESPA paid the remaining amount due to send all K-6 kids to festival.
- Rendezvous week has now become Rendezvous month to be able to fiy all events into the schedule.
- French Immersion student numbers at Ardrossan Elementary are at 181


## Ardrossan JR / SR Update - MJ Nam

- MJ reported she sends out Weekly Bison track update to all Ardrossan Jr/Sr weekly
- MJ will add CPF info to increase membership about draw for Oil King tickets for new membership
- MJ reported French immersion numbers at AJR/SR- 131 Junior / 146 Senior
- Grade 9 has 44 students - 25 going on Quebec trip May Long weekend.
- Board request how we can get Student Volunteers to do more for the payment they receive. MJ will discuss but it can get tricky as students have very rigid case load for academics. Difficult to pull them from educational hours. Board suggest in future we make a required volunteer credit prior to giving funding to Grade 9 trip. Board also suggest parents of those students do volunteer shift to receive credit.
- Jr High Dance is same day as Carnaval so not educational hours being missed for those who come to help run stations.
- Scholarship - MJ appreciative for the ongoing support of same, CPF - only French immersion related one
- This year there are 43 students eligible to write the DELF exam -
- EIPS pays for Exam, previously CPF pays for DELF prep package. Last year voted on CPF would pay if student held CPF membership. $\mathbf{7 5}$ prep package
- Discussion on current membership, How to get people to hold membership throughout years
- EIPS holding French immersion Secondary Information French immersion night Dec 5, Sherwood Heights hosting, Faculty St Jean also presenting
- Grade 9 Substitute cost for Grade 9 French field trip \$1434 current cost for 2 substitute teachers. MJ requesting same from CPF.

Jill Herbert Motion to pay $\$ 1434$ to Ardrossan Jr/Sr Ady Arbuckle $2^{\text {nd }}$ motion - Motion carried. Cheque written to Ardrossan Jr/Sr High -MJ Nam for same

Discussion had between board members of how we can reach those Grade 9 kids to get more support from in order for us to pay for those substitute teacher costs. Connie reported we previously gave $\$ 800.00$ for substitute and last year paid $\$ 1375$. This year fee has gone up again.

- Motion by Val CPF will pay up to 1000 for Substitute teacher for 2020-2021 Grade 9 French trip, Ady $2^{\text {nd }}$
- Suggestion made that in June we can give the Ardrossan Jr/Sr school information so they present at their Grade 9 French trip initial meeting to inform parents or same. Increase to their trip fees.
- Recommendations for all those Grade 9 to have active membership
- Pending membership for Grade 4 2020-2021 field trip - subsidize 25 per kid
- Gave $\$ 250.00$ and $\$ 1434$ to Ardrossan Jr/Sr High - Membership list reviewed, there is less and less families from Jr/Sr High and from AES. 30 families currently registered.
- Hard to convince people to hold membership if they get the services CPF offers anyway.
- Discussion about a "Love" Dance in February, held by CPF. CPF members get discount / in for free to event. Have concession for cash.
- Ady suggested at CPF run events (Carnaval /BBQ), ask for families to bring bottles to do Bottle Drive for CPF. Currently AESPA does for 2X parent teacher interviews and the same works. Could ask Jr / SR kids to also contribute at those events if trailer was outside.
- Connie still interested in Pastry fundraiser through Fife $n$ Dekel. Allison Usher to get more information for November meeting
- Board to further discuss fundraising options at next meeting
